THOSE CHUPCH WEDDINGS

Marriage is decidedly an institution ordained by God, and most certainly spiritual consideration must be a part of the promise of men and women to be husband and wife. But I remain unconvinced at this date that the usual ceremony that is labeled a "church wedding" is a work of the congregation and thereby a fit event to be preformed in its building.

Think with me on this. Formal weddings are characterized by a display of ornate clothing, the lighting of candles, the singing of secular songs, the processional, the recessional, etc. Is this a description of a religious service? Instrumental music is used sometimes, even in church buildings, and is almost always used if the ceremony is preformed elsewhere. This must prove to all Christians that it must not be a religious service. Rather, the formal wedding is a secular custom, with Bible reading and or teaching on marriage occupying a part of the whole picture. The only recorded wedding Christ attended was obviously a social and secular occasion. The wine and merry-making were certainly not a part of a religious service.

We might liken the matter to an inaugration ceremony of a government official. Government is ordained of God. (Rom. 13) With most any installation in office there is prayer offered and sometimes a Bible reading. But does this make the ceremony a religious service? If so we could use the church building for inaugurations. I hold that our so-called "church weddings" are a true paralled. (What is a "church wedding" anyhow?) The ceremony in both instances is basically a social-secular occasion, with the religious flavor a small part of the whole proceedings.

Yes, marriage is ordained of God, but not the ceremonal trappings that social custom dictates today. The idea of being married "by the church" originated with the Catholics. The Catholic Church seeks such complete control over her subjects from birth to death that everything must be done "by the church". To be refused to be married or buried by the church is not to be taked lightly by Catholics. But how can Christians be married "by the church"? Think about it.

- 5. Neither is a "religious servious" with pagentry, secular songs, etc. occupying a good part of the time.

- 11. Could one have a 50 year anniversary in the building?
- 12. Would the building be a lawful aid if it were used for other than the work of the church?
- 13. Where does one "draw the line" for the expediency of the building if not at that which directly bears upon the work of the church?
- 14. If marriages are a work of the church then the entire church must be present ... why send invitations to a select few?
